

# THE VIBRANT DYNASTY/CLIENT CONTRACT

This Agreement is between Vibrant Dynasty Eventz (“Vibrant Dynasty”) and the Client. By proceeding with our services, both parties agree to the following terms:

## 1. ENQUIRY & CONSULTATION

**1.1** Vibrant Dynasty provides a three (3) working day enquiry period, during which all questions are addressed and relevant information is shared.

**1.2** After this period, a consultation fee of ₦150,000 will be charged.

**1.3** This consultation fee is deductible from the final service cost if the Client proceeds with booking.

## 2. SERVICES & PACKAGES

**2.1** Vibrant Dynasty will provide the Client with an Event Package document showing available services and prices.

**2.2** Once services are agreed, a detailed invoice will be issued outlining all services to be provided.

## 3. PAYMENT TERMS

**3.1** 80% of the total service fee must be paid to officially commence work.

**3.2** The remaining 20% balance must be paid at least two (2) weeks before the event date.

**3.3** Failure to complete payment within the stated timeline constitutes a breach of contract, and Vibrant Dynasty will not be held responsible for incomplete or disrupted service delivery.

## 4. NO-REFUND POLICY

**4.1** All payments are non-refundable once made, regardless of cancellation, postponement, or change of plans by the Client.

## 5. CANCELLATION POLICY

**5.1** If the Client cancels the event after payment has been made, all payments remain non-refundable.

**5.2** If cancellation occurs before full payment, any amount already paid will still be retained by Vibrant Dynasty to cover administrative and preparatory costs.

## 6. RESCHEDULING POLICY

**6.1** The Client may request to reschedule an event subject to availability.

**6.2** Rescheduling requests must be made in writing and approved by Vibrant Dynasty.

**6.3** Additional costs may apply due to vendor availability, price changes, or logistics.

**6.4** Payments already made will be applied to the new date, but no refunds will be issued.

## **7. FORCE MAJEURE**

**7.1** Vibrant Dynasty shall not be held liable for failure or delay in performance due to events beyond reasonable control, including but not limited to:

- \* Acts of God
- \* Government restrictions
- \* Natural disasters
- \* Civil unrest
- \* Strikes or vendor shutdowns

**7.2** In such cases, both parties agree to work together in good faith to reschedule the event where possible.

**7.3** Force majeure events do not entitle the Client to a refund.

## **8. MEDIA & CONTENT USAGE**

**8.1** The Client grants Vibrant Dynasty permission to photograph, record, post, and publish content from the event for marketing and promotional purposes across all media platforms.

## **9. VENDOR MANAGEMENT**

**9.1** All vendor payments shall be made through Vibrant Dynasty, with proper records maintained.

**9.2** All vendor balances must be paid before the event weekend to allow vendors finalize arrangements.

**9.3** Failure to pay vendor balances on time constitutes a breach of contract, and Vibrant Dynasty will not be responsible for any resulting issues.

**9.4** If the Client chooses to use personal vendors, all communication and coordination will still be handled by Vibrant Dynasty.

## **10. ADDITIONAL SERVICES**

**10.1** Any services or activities not included in the original agreement will attract additional charges, which must be approved and paid for by the Client.

## **11. ACCOMMODATION**

**11.1** Where applicable, the Client agrees to provide suitable accommodation for Vibrant Dynasty staff for the duration of the event weekend.

## **12. GOVERNING LAW**

**12.1** This Agreement shall be governed and interpreted in accordance with the laws of the Federal Republic of Nigeria.

## **13. ACCEPTANCE**
